We agree to maintain a US\$ deposit amount in our account with you equal to at least 150% of the total credit limit approved on all Credit Cards issued by you at our request (the "Collateral Amount"). To the fullest extent permitted by law, we hereby charge all rights, title and interest in and to the Collateral Amount and the debt represented thereby to you by way of first fixed charge as security for the payment and satisfaction of all obligations and liabilities on the Credit Card(s). We acknowledge and accept that unless we have your written consent or you have confirmed that the obligations and liabilities on the Credit Card(s) have been irrevocably paid and discharged in full, we shall not be entitled to withdraw the whole or part of the Collateral Amount held by you, or assign, transfer or otherwise dispose of all or any part of any right title or interest in or to such Collateral Amount. We further accept that the Collateral Amount shall be a continuing security, shall extend to the ultimate balance of the liabilities on the Card(s) and shall continue in force notwithstanding any intermediate payment in whole or in part of such liabilities.
